I understand that: (i) a belt will be attached to the waist of my child in order to enable a skating instructor to lift the child three to five feet (3'-5') off the ice surface; (ii) the child will be pulled along and then lifted during the jump; and (iii) the rope and pulley, which are part of the apparatus, are attached to a wire that is stretched above the ice surface.

RELEASE, WAIVER OF LIABILITY AND EXPRESS ASSUMPTION OF RISK AGREEMENT FOR USE OF JUMP HARNESS (must be completed)

In consideration of Gilmour Academy ("Gilmour") allowing myself or my minor child to use Gilmour's ice skating facilities and participate in ice skating programs or activities at Gilmour's ice skating facilities, I acknowledge that I understand the nature of the skating activities in which I, or my minor child, will participate and that I, and/or my minor child, am qualified, in good health, and in proper physical condition to participate in such activities. I fully understand that skating involves risks of serious bodily injury, including permanent disability, paralysis, and death, and that these and other risks may be caused by my own actions or inactions, the actions or inactions of others participating in the activities, the conditions under which the activities takes place, or the negligence of Gilmour or its officers, Board of Trustees, employees, volunteers, agents, and any sponsors and advertisers of any event at Gilmour in which I participate, and that there may be other risks either not known to me or not foreseen at this time; and I fully accept and assume all such risks and all responsibility for losses, costs, and damages I, and/or my minor child, incur as a result of my, or my child's, participation in any ice skating programs or activities at Gilmour's ice skating facilities.

I hereby release, discharge, and covenant not to sue Gilmour or its officers, Board of Trustees, employees, volunteers, agents, and any sponsors and advertisers of any event at Gilmour in which I participate (collectively, the "Released Parties") from all liability, claims, demands, losses, or damages on my account caused or alleged to be caused in whole or in part by the negligence of the Released Parties, or any of them, provided, that, this Release, Waiver of Liability and Express Assumption of Risk Agreement shall not apply to any liability, claims, demands, losses, or damages arising out of the gross negligence, or intentional, willful or wanton misconduct, of the Released Parties, or any of them. If I, or anyone on my and/or my minor child's behalf, makes a claim against any of the Released Parties which does not arise from their gross negligence or intentional, willful or wanton misconduct, I will indemnify, defend, save, and hold harmless each of the Released Parties from any loss, liability, damage, or cost which they may incur as the result of such claim.

I acknowledge that I have read this Release, Waiver of Liability and Express Assumption of Risk Agreement and fully understand it.
